
- Jennifer Esposito Springett in to discuss funding application. Application must be submitted by March 21, 2025

 - A place to pray at a bench or a marker
 - Reach out to look for another partner to help with the design
 - IFNA to be a possible partner
 - Residential School Survivors to sit on the committee to strengthen application
 - Do a write up about the survivors with the grant application
 - Joan will look into a partnership
 - A circle memorial, with hard surfaces, rocks etc. in the Northern part of the Cemetery
 - No funds for searches at the moment



- Brent suggested we bring a member of Bring the Children Home to discuss plans
- Reece will give name of who to contact
- Megan or Michelle will reach out
- Would like to have a keynote speaker have traditional crafts out
- Darlene has a disc to donate to the Library, about Residential Schools
- Would like to allocate 2/3 m of the money to the hardscape of the memorial, can look at the United and Anglican Church for help with funds
- Bringing Elders in from the North will be well be over \$100 000
- Could look at NAN to help transport Elders
- Will put application in now
- · Jen can help with grant and project description
- Could look into Cradle Boards all different kinds and sizes, Jolene Banning makes them
- Children were 3-4 years old when they were taken into Residential School
- 75% will be given upon approval of grant
- 25% will be given after completion of plan
 Who is taking the lead on the Grant and plan a committee with Survivors, will try to find funding for marker.
- Meet the Survivors, find an artist to design a piece. Put out an RFQ for Artists to design a piece
