Note that the final closing for the Granular "A" Request for Quotation will be **June 28th**, **2024** at noon (local time). In addition, the total volume of material requested must be delivered to the specified location by **JULY 19**th, **2024**.

SUPPLIER:

PLEASE QUOTE ON THE FOLLOWING:

- 1. To supply & deliver a total of **650 cubic meters (850 cu. yards)** of Granular "A" in accordance to OPSS.MUNI 1010.
- 2. Delivery site will be 41 Fifth Avenue, Sioux Lookout.
- 3. In lieu of delivering the entire quantity of product to the Public Works yard, 41 Fifth Avenue, the successful Contractor may be asked to haul and spread some quantity of the product to specific gravel roads within the Municipality. It is expected that the mileage incurred for delivering the product to the Public Works yard or hauling and spreading to specific gravel roads would be similar. However, if it is determined that a road which is requested to have graveled delivered is in excess of the mileage that would be incurred for typically delivery, Public Works and the successful Contractor will discuss an hourly rate for the delivery of the product in addition to the unit rate accepted.
- 4. The Contractor will notify the Public Works Department a minimum of 48 hours prior to hauling to any site.
- 5. All product must conform to OPSS.MUNI 1010.05.02. In addition, failure to meet the specifications of OPSS.MUNI 1010 Table 1 and Table 2 will result in rejection of any deficient quantities from the total volume of material requested. The Contractor will be responsible for removal of any rejected material at no additional cost.
- 6. Failure to deliver product by the specified delivery date will result in being charged liquidated damage charges of \$150 per week for every week not delivered.
- 7. Quotation sent via facsimile **WILL NOT** be accepted.
- 8. The Contractor should not expect the Municipality to incur additional costs due to weekend hauling by the Contractor. The Contractor is to notify the Public Works Department when delivery is to be made to the stockpiling site.
